## ADOPTION POLICIES:

- You must be 18 years of age or older to adopt an animal.
- · A current photo ID (driver's license or state ID card) is required to process an adoption.
- Some species have limits on the number that can be adopted at one time or may have a
  requirement they be adopted together or may have restrictions regarding other pets or
  young children. Please understand these restrictions are in the animal's best interests
  to give them the best chance for success in a new home.
- All dogs, puppies, cats, kittens, rabbits and ferrets will be spayed/neutered prior to going home.
- To provide permanent identification, all dogs, puppies, cats, kittens, rabbits and ferrets receive a microchip implant. The microchip is registered at the time of adoption.
- Adopted animals can be taken to veterinarians for a free wellness exam within fourteen (14) days of adoption.
- While we hope your pet selection is successful and permanent, we do offer a 30-day trial period from the date of adoption during which you may return the pet for any reason. A return/replacement voucher will be issued that you can use to adopt another animal. No refunds will be given.
- If at any time you can no longer care for your pet and cannot find a suitable home, we ask that you return the pet to the animal shelter.
- The shelter reserves the right to refuse any adoption.
